As the Knowledge-Based Bio-Economy can assure a healthier environment and a better quality of life for the citizens of the modern European society, **all Member States should handle the issue of the bioeconomy as a priority.**

During the Presidency we will take into special consideration the reform of CAP beyond 2013. The aim of the Hungarian Presidency is to have an unanimous Council Conclusion by spring 2011 on the Commission Communication of November 2010. There will be numerous legislative tasks related to the simplification of CAP and its alignment with the Lisbon Treaty.

During the presidency Hungary would like to foster the competitiveness of the European agri-food sector. It is a long-term objective to promote the agricultural R+D and innovation, the development of the European Research Area and its linkage with a social dimension.

Beyond this we believe that it is important to carry forward the legislative processes of the Belgian Presidency such as the regulation of the milk sector and

of animal health, the issue of agricultural quality assurance, genetically modified organisms, sustainable production and resource efficiency.

Once again, I would like to thank the organisers and the participants for bringing this conference to a successful conclusion. Thank you for the fresh thoughts and new approaches, which you shared with us all. **I can assure you that the Hungarian Presidency will do its utmost to carry forward the work of the Belgian Presidency.**

At the same time, **I would like to ask you to support the Hungarian Presidency as well with your constructive suggestions and ideas**, to help it to fulfil its tasks, with special attention to the vision, which was conceived during this conference today.
